Established in 2003, the aim of the Award Day is to celebrate the achievement of the South African mining industry towards our journey to Zero Harm.

We are pleased to open nominations for the 2025 Awards in the following sections:

- A. **Safety:** The level of management appointment for company/mine participating for the Safety Awards is a MHSA appointment 3.1(a) or 4.1 appointee.
This recognition celebrates organizations who have experienced improvements in their TIFR evaluated over a 3-year period. This award is open for business partners.
- 1) Category 1: Annual Total Injury Frequency Rate (TIFR) Improvement
 - 2) Category 2: Best in Class Total TIFR
 - Category 3: Significant Safety Achievements
- B. **Environment:** Submissions can be done by persons working in the Environmental Department on a Mine
This recognition celebrates a mine that has conducted/managed project(s) focusing on improving the environmental condition/situation at such a mine. To qualify for an Environment Award, the mine must submit a Technical note/paper indicating the following:
- Scope of the Project
 - Desired Outcomes
 - Activities Conducted
 - Progress/Achievement vs Desired Outcomes
 - Current Status/Sustainability
- C. **MiNESAFE Health Awards - categories**
The Minesafe Health Sub Committee will consider the following parameters for the adjudication of Minesafe Occupational Hygiene & Occupational Medicine awards.
- 1) Occupational Hygiene
 - Improvement in Personal Noise Exposure Monitoring
 - Improvement in Personal Airborne Pollutant Exposure Monitoring
 - Improvement in Milestone Reporting (Performance & reporting)
